Block Level awareness Program

Grihini with support of Sightsavers organized awareness program in four block of Balodabazar District Balodabazar, Palari, Bhatapara, Simga on 21.06.2018, 22.06.2018, 23.06.2018, 25.6.2018 in which 372 (Male: 258, Female: 114) people attain awareness program. The main objective of this awareness program is to sensitize all the stakeholder and person with disabilities (PWDs) about PWDs rights and entitlements, RPWD Act 2016. In this program Zila Panchayat,

village sarpanch, Anganwadi worker, mitanin, NRLM active women, and non-disabled person, PWDs took active participation. Awareness program commence with welcoming of all the stakeholder and prayer song which was followed by introduction of Chhattisgarh Social Inclusion Program by Grihini staff.

DPO members of each block aware all the stakeholder about government schemes for PWDs, rights and entitlement, RPWD Act 2016 and they also aware stakeholders. During awareness program various competition was also organized such as candle lighting, Balloon blooming, question answer session and winner of all these competition were also given prize. Apart from this DPO members also share challenges and success stories of people living with disability. Which help to make the participants experience the disability and realize how challenging the life of PWDs is.

At last of every awareness program DPOs of every block aware PWDs and non-disabled person about, employment opportunities, education. It was concluded that in every block there was a positive reaction from the participants towards supporting physically challenged person. Some participants shared that this awareness program was an eye opener because till now they have been thinking that PWDs are incapable of doing anything. It is therefore expected that this awareness program can help change the attitude of the people towards disability and make safe and accessible environment.



State Level Advocacy Workshop

After that through an open discussion, participants were asked to share their opinion on forming the state level DPO network in which each member share their views in which they also discuss about problems, need and solution of PWDs.

In next session participants were asked to finalize name for state level DPO network and they decided to name state level DPO network "Mor Sang Chalaw". Then through an open session participants were asked to prioritize the state level advocacy agenda relating to PWDs issue. During the discussion they identify few advocacy issues such as, accessibility, inclusive education, and employment of PWDs, increment in pension, coordination committee formation at the district level, awareness among PWDs, government authorities and line departments. The meeting concluded with all DPOs and partners taking responsibility for state level DPO network.



Orientation Training on Enabling Environment Study

A one day orientation training on enabling environment study was organised by Grihini with support of Sightsavers at Mahila Sablikaran Kendra Kuthroud on 29th June 2018 to create a barrier free society for all in which 30 DPOs (Male: 19 female: 6) from 6 district Balodabazar, Raipur, *Mahasamund*, Kanker, Balod, Dhamtari were present. The training programme commence with introduction of participants and Trainer Mr. Tomesh Verma, and Ishwar Prasad Chatta. Participants were asked to sum up what they understand by the term "Accessibility" then trainer stressed the fact that accessibility is for everyone (access for all) not only people with disabilities but also pregnant women, the elderly, people carrying heavy luggage or families with small

children needs access features.

Trainer share how an accessible physical environment benefits the entire society, not just persons with disabilities. The persons with disabilities are entitled to a barrier free and disability friendly environment to enable them access buildings, roads and other public amenities. The government and private agencies should eliminate obstacles and barriers in indoor and outdoor environment including schools, medical facilities and workplaces. Through presentation trainer showed videos and photos to show different barriers to accessibility in everyday environments, e.g. stairs with no ramps, steep ramps, no handrails, narrow doors, inaccessible toilets, open drains, gratings etc which help Person with disability for understanding access needs and identifying barriers, physical, social, structural and attitudinal barriers. Trainer also discuss about road safety measures such as road signs signal crossings, stop lines and zebra crossing, traffic signal, audio beeper and audio announcement system.

At last trainer conducted practical session which was very effective in showing the challenges faced by PWDs every day. In which Trainer aware Person with disability about proper measurement of handrails, tactile, stairs, ramp, standards and sizes accessible toilets, parking, elevator. This was followed by group photographs and vote of the thanks.
