District level workshop with Animal Husbandry Department on Backyard Poultry and Goatery Management

Male-20 , Female- 6 TOTAL 26

A one day district level workshop on Goatery and backyard poultry management training was organized by Grihini in collaboration Animal Husbandry department balodabazar on 1 August 2018 in which 26 (Male-20 , Female- 6) Person with Disability form Palri, Bhatapara, sigma, balodabazar took part. Session start with welcoming of officials of Animal Husbandry Department and Person with disability members. After that presentation of was given by DPM about CG social inclusion project in which he highlights beneficiary who are engaged in livestock for their livelihood which was followed by video clip of Grihini.

Then after Dr Vandana Ratre VAS ask PWDs that how many of them are doing goatery, poultry and how they are taking care. After that through powerpoint presentation she explain how they can earn their livelihood through goatery and also gave different example of beneficiary of Balodabazar that how they started doing goatery and now they are doing this at big scale. Then Dr Vandana explain how to identify healthy and unhealthy goat. She also discuss about characteristics of good goat such as soft skin, size of stomach, shiny hair etc which every beneficiary must know in order to manage goat. She also discuss about different breed available in market and which breed is suitable for Chhattisgarh so that they can earn good amount of money. Dr Vandna also discuss about some common disease such as PPR, FMD (Foot and mouth disease), E.T (Entro toxemia), Brucolisis, Pox and she also about its symptoms, use vaccination. At last she also explain about government schemes from where eligible beneficiary can get good breed of goat.



In second half Dr M Kurashiki gave PowerPoint presentation on Backyard poultry management he said that backyard poultry is an old practice in rural India. Most of the backyard poultry comprises of rearing of indigenous bird with poor production performance. The potentiality of indigenous bird in term of egg production in only 70 to 80 egg/bird/year and meat production is also very less. However backyard poultry production can be easily boost up with improved varieties of chicken and can promise a better production of meat and egg.

Through presentation he also explain about important characteristics of good chicks such as attractive and coloured plumage, escaping capacity from predators, disease resistance, hardy in nature, mothering ability, adaptability in village condition etc. He also focus on backyard poultry does not need any housing facility but it should protect the bird from rain, sun, predator and suggest that poultry house must have bulb fitted above to keep chicks warm. He then also discuss about diseases that can be easily cure through regular vaccination, deworming At last he told that backyard poultry feed cost is considered to be minimum, because chicks are loose for scavenging in open yard which minimize feed cost.

The workshop concluded with thanks giving by Ms. Rupa Srivastava Director, Grihini, and she said that to improve the socio economic status of the person with disabilities, backyard poultry is a handy enterprise with low- cost initial investment, but high economic returns which will help them in long run. This was followed by group photographs.



Workshop on Conducting Accessible Election - Inclusion Of Person with Disabilities

Grihini in collaboration with District election commission and social welfare department organize one day district level workshop on accessible election for Person with Disabilities on 22nd September 2018 at Hotal Park Plaza Balodabazar. In which 41 (Male- 31, Female- 10) PWDs from balodabazar district took active participation. Session start with welcoming of participants and master trainer and director of Social welfare department which was followed by video clip of Grihini CG social inclusion program.

After that small role play was done by DPO members to aware what problem they face by them how people interacted with them in their village, what problem they face during voting and in voting booth. Through this they try to aware officials of election commission so that they can find the solution for the same.

Then Master trainer Mr, Rakesh Singh, Saamartya and Mr. RudraKumar Chandrawansi explain process of voting for all 21 types of person with disabilities. Then after they also conduct demo session with election commission officials and show what problem face by PWDs in polling booth and also suggest what need to be done. After seeing role play and demo session Mr. S Tiwari , State level master trainer said that this they will provide ramp at polling booth so that PWDs reach easily, signage board will be used at every polling booth, they will also provide assistive device to PWDs at polling booth and also mention that if any PWDs reach to any polling booth they are not required to stay in queue they are given special preference is given by election officer.



Mrs. Asha Sukla, Director, Social welfare department also said election commission of India said that “Leave no voter Behind” with special focus on PWDs and the theme of inclusion of PWDs has been given a special focus in the election commission of India Strategic plan 2016- 2025. At last she said our vote is our power let’s make sure we use it, and we all have to vote in every year election.

At the end of workshop master trainer conduct practical session for using VVPAT electronic voting machine. This was followed by thanks giving by Mrs Rupa Srivastva.



Skill Development Training on Phenyl and Detergent powder making for Person with disabilities Self Help Group

Male- 18 , Female- 7 Total -25

Summarize the event – contextualize by briefly relating with the objective of the event and/ or providing situational analysis of need of event; mention the role of partners and Sightsavers; chief guest and other dignitaries present (mention designations); date, venue, participants (men & women)

A three day skill development training on Phenyl and detergent powder making training was organized by Grihini with support of sightsavers in Mahila sablikaran kendra, kuthrod on 23rd to 25th September 2018. In which 25 (Male- 18 , Female- 7) person with disability from balodabazar district four block palari, bhatapara, sigma, Balodabazar, 8 self-help group members took part so that they can start doing livelihood activity in their group with very small investment.

Day 1

Session start with welcoming of trainer and participants by Mrs. Rupa Srivastava which was followed by introduction of participants and trainer. After that Mrs Shipra Devi, Trainer Nivedita Foundation ask person with disability why they need money and for that what they have to do in order to earn their livelihood. After that she divides PWDs in five group and gave them group activity to note down why money is important in every part of life and how they will market their product in order to capture market. After that presentation was done by all five group. Then after Mrs. Shipra and Mr. Santhan said that there are many business options which need very small investment but if done with dedication can fetch good margin of profit and



starting a business of liquid phenyl and washing powder is one of them.

Day 2

After that Trainer conduct the practical session for making liquid phenyl by using pine oil and Emulsifier and said that With just these two materials SHG members can manufacture liquid phenyl. The pine oil works as a disinfecting agent and the emulsifier helps to mix and stable the pine oil with the water Mr Santan Das, Trainer told SHG members that It is the simplest way of manufacturing liquid phenyl, although there are also other procedures available for phenyl manufacturing. Trainers said that for producing concentrated white phenyl, SHG members need to make a solution of 70 % pine oil and 30 % emulsifier. And they need following raw material such as concentrated pine oil (the concentration should be between 22 % to 26 %), emulsifier or pine oil emulsifier, a container or bottle to keep the finished product.



PROCESS: – FOR MAKING ONE LITER OF LIQUID PHENYL

STEP 1 –

Combine the pine oil and emulsifier in a container with enough capacity to hold both the solutions as the above mentioned ratio and blend properly. Once the stirring is completed, it will appear like a concentrated white phenyl.

STEP 2 –

Next step is to mix the concentrated white phenyl with water. The ratio can be 1:20 or 1:40 as required. Again mix the concentrated white phenyl with the water in a container and can use machine or spoon or any other thing to mix and blend.

Trainer said that with one litre of concentrated white phenyl one can produce 20 **litre** of liquid phenyl, i.e. with the ratio of 1:40.

At last trainer said that liquid phenyl manufacturing unit SHG members does not need to invest a huge capital. Trainer also said that to start from small scale and gradually increase the production by implementing advanced procedure with the use of different types of machineries etc. The margin of profit in phenyl manufacturing is very high. They also Suggested SHG to promotion their product because it is also an important part of the business. Hospitals, nursing homes, public places, local retailers or wholesalers are the big customers of liquid phenyl. Mrs. Shipra Devi also told that SHG members at early stage of business giving free samples or in discounted rates and which will help SHG members to grow their business quickly.

Day 3

Session start with recap of previous day practical session after that trainer discuss about Detergent powder or laundry washing powder manufacturing and said that any SHG can initiate a detergent powder making business with moderate capital investment and can easily sell in rural market. Because washing powder is an important ingredient for cleaning and washing purpose and use by everyone in rural area as well as in urban area. After that trainer conducted practical session and told SHG members that they must take precaution by using gloves, mask.

Ingredients for preparing 5 kg washing powder

Acid slurry – 750 gm

Soda Ash- 2.5 kg

Sodium tri polyphosphate- 250gm

Corboxy methyle cellulose- 250gm

Trisodium phosphate- 250 gm

Guaubers salt – 250gm

Brightner and Perfume

PROCESS: – FOR MAKING washing powder

Step 1

Neutralized acid slurry with soda ash mixture and keep for one hour.

Step 2

Blend other ingredients such Sodium tri polyphosphate, Corboxy methyle cellulose, Trisodium phosphate, Guaubers salt, Brightner and Perfume to neutralized acid slurry.

Step 3

Packaging of Washing Powder in packet of 100g , 500g, 1Kg, 2Kg & 5kG.

Closing ceremony was organized at the end of training program in which chief guest Mrs Rashmi Panpalia, Mrs Srivastava , Mr Vabhav , (Ultra tech, CSR), Mrs Srish Mishra (Ultra tech CSR) were also present . They also motivate SHG member to start their own enterprise so that they earn their livelihood on sustainable basis.

Mr Srish Mishra (Ultra tech CSR) said awareness of hygiene has increased a lot in last few decades in both rural and urban areas. SHG member can sell their product in hospitals, public places like stations, airport, school, anganwadi etc. He said that we can find a bottle of phenyl in every household nowadays. The demand of liquid phenyl and washing powder is rapidly increasing whereas there are very few phenyl manufacturing units to cater to the demand. So it's a good option to start liquid phenyl washing powder manufacturing business in SHG and it doesn't require high investment.

After that PWDs SHG member share what they have learn during 3 day training. This was followed by thanks giving to participants as well as chief guest.



Awareness on PWDs on Gender Equality and Women Rights

65 PWDs women

Grihini has organized a one day workshop on Gender equality and PWDs women rights in collaboration with Women and Child Development Department Balodabazar on 27th September at Hotal Park Plaza. In which 65 PWDs women were present. Inauguration of workshop was done by Mr. Vipn Jain District Program Manager, Women and Child Development Department, and Mrs Manisha Vatsa, Consultant, MHRD by lightning of Lamp which was followed by video clip of Grihini CG Social Inclusion program.

Mr. Vipn Jain District Program Manager, Women and Child development department said that all PWDs women must aware of their rights such as right to live, free from violence, slavery and discrimination, to be educated, to own property, to vote and to earn a fair and equal wage. He also told if PWDs women require any support from Women and child Development Department they can directly contact him in his office.

In next session Mrs Manish Vatsa, Consultant, MHRD ask all women to share what problem they face in their life and participants also share what society think of them and how they behave some women said that they are being tortured in their family because they are differently abled. Mrs. Manisha Vasta explain the term domestic violence and highlights few point such as Physical abuse, sexual abuse, Verbal and emotional abuse, Economic abuse she also gave different example of all domestic violence by showing video clips.



Trainer then discuss about Protection of women from domestic Violence Act 2005 and said it an act of Parliament of India to Protect Women from domestic violence it was bought in to force by Indian government from 26 October 2006. The Act provides for the first time in Indian law a definition of "domestic violence", with this definition being broad and including not only physical violence, but also other forms of violence such as emotional/verbal, sexual, and economic abuse. She said any woman who alleges to have been subjected to any act of domestic violence by the offender or any person may file a complaint on her behalf and child is also entitled to relief under the Domestic Violence Act. The mother of such a child can make an application on behalf of her minor child (whether male or female). In cases where the mother makes an application to the court for herself, the children can also be added as co-applicants. Complain can be made to a police officer/Protection Officer/Service provider (an NGO) or Magistrate and there is also provision for shelter home and medical aid for women. Reliefs under the Domestic Violence Act can also be asked for in other legal proceedings e.g. petition for divorce, maintenance, Section 498A IPC.

At last she also discuss about one stop center, Women help line 181, Child helpline 1098, single helpline 112, Sanjeevani express 108 and also show video clip of Child Sexual Abuse and told women's to share this concept of safe and unsafe touch, with their children so that they can be better equipped to protect themselves and take help from trusted adults if ever caught in a similar situation. The workshop concluded with thanks giving by Ms. Rupa Srivastava, Director, Grihini.
